### **Championship History**

This year marks the 62<sup>nd</sup> playing of the Alabama Girls State Junior Amateur Championship and the third time that Valley Hill Country Club has hosted the Girls State Junior Amateur Championship. Frances Brown of Mobile won the title in 2024 at GlenLakes Golf Club (Dunes/Vista). The Championship was first played in 1963 with Judy Jehle winning the inaugural event. Michaela Morard holds the record with 5 victories (2015, 2017-2020).

### **Valley Hill Country Club Policies**

*Cell Phone Policy:* Cell phones may only be used on the golf course in case of an emergency, to call for a ruling, input live scores, view tournament leaderboard or use as a distance measuring device. We ask that phones are set to silent while on club grounds. Silent communications (text, email) may be used inside buildings. Verbal communication (phone calls) must be outside buildings.

*Parking:* There is a limited amount of parking available at the host club and we ask that players, caddies, and family members carpool as much as possible.

*Dress Code:* Appropriate golf attire must be worn. Males must wear tucked-in shirts with collars and sleeves, slacks, or Bermuda shorts. No cut-offs, denim, cargo pants or cargo shorts are permitted. The dress code applies to players, caddies, and spectators. Valley Hill Country Club is a soft spike facility; the penalty for non-compliance is disqualification.

*Coolers:* Personal coolers are not allowed.

*Personal Items:* Make sure not to leave any valuable personal items unattended. It is best to leave your valuables locked in your automobile. Neither the AGA nor the host club will be held responsible for any lost or stolen personal items.

*Accepted Forms of Payment:* Club accepts cash and credit cards.

### **Practice Rounds and Practice Facility**

Official practice rounds will be on Sunday, June 1. You must call the golf shop (256-883-7620) to schedule your practice round for this day. Make sure to identify yourself as an Alabama Girls' State Junior Championship participant. It would be helpful if you make your own group before calling. Do not just show up at the course and expect to be accommodated for a practice round.

There is a **MANDATORY** \$30.00 fee for each practice round. Players are limited to playing one ball except from the teeing ground. Players are welcome to use the practice range and putting green throughout the championship.

### **Starting Times**

Starting times for Round 1 will be available on May 29 by 5:00pm. Check the AGA website at [www.alabamagolf.org](http://www.alabamagolf.org) or call the AGA office.

### **Championship Format and Schedule**

Championship is conducted at 54 holes of stroke play. The lowest score for 54 holes will be the Champion. In the event of a tie for the overall Championship only, a hole-by-hole play-off will be held immediately following play. The play-off holes and their order of play will be determined by the Committee.

<b>Sunday, June 1</b>	Practice rounds. 7:30am-3:00pm: Player Registration in the Clubhouse Foyer adjacent to the golf shop.
<b>Monday, June 2</b>	Round 1: Tee times at 7:30am off #1 & #10 tees Field re-grouped according to score.
<b>Tuesday, June 3</b>	Round 2: Tee times at 7:30am off #1 & #10 tees Field re-grouped according to score.
<b>Wednesday, June 4</b>	Round 3: Tee times at 7:30am off #1 & #10 tees Awards ceremony immediately following play at scoreboard.

### **Pace of Play**

The AGA wants all players to enjoy competing in our events. Pace of play may differ depending upon the venue, weather and course conditions. Every player is accountable for playing at an acceptable pace; therefore, we need your help. Please observe the following guidelines to help ensure a pleasant tournament experience for all:

- Make sure to keep pace with the group in FRONT of you. The group behind should keep pace with your group and so forth.
- Go directly to your ball. If sharing a golf cart, drop-off the player farthest from the hole then proceed to the other ball.
- Be ready to play when it is your turn.
- Keep practice strokes and time taken to read putts to a minimum.
- Play a provisional ball if your original ball may be lost or out of bounds.
- Keep time taken at the snack bar or between nines to a minimum.

If everyone does their part, then 4½ hours should be the maximum time taken to play a round of golf at an AGA tournament. Following the lead of the USGA, the AGA has developed a pace of play policy, based on Rule 5.6b and Model Local Rule 8K that is fair to every competitor.

\*Note: a group may receive a "friendly reminder" of their position regardless of pace of play guidelines.

### **Maximum Allowable Time**

The maximum allowable time is the maximum time considered necessary by the Committee for a group to complete its round. This is expressed in a per-hole and aggregate time format and includes all time associated with playing the game, e.g., for rulings and walking times between holes.

Both the specific maximum time allotted per hole and for the completion of 18 holes at AGA championships will be denoted on each player's AGA issued scorecard.

- A competitor's time to play begins when the competitor has had a reasonable opportunity to reach his or her ball and when it is the competitor's turn to play and can do so without interference or distraction. Penalties are applied individually, but more than one competitor in a group may be penalized.
- In general, competitors in a group are subject to being timed at any time but specifically when the group is deemed to be out of position and over the allotted pace of play guidelines.

Note that a group that is out of position at any time may be asked to close the gap regardless of pace of play guidelines. A group is out of position if they are over their maximum acceptable pace of play and more than 15 minutes behind the group ahead of them. The first group off either side is out of position if they are over their maximum acceptable pace of play.

### Range Fees; Push Carts

- *Practice Rounds:* Practice round fees are not included in the entry fee.
- *Championship Site:* All range fees during the championship rounds are paid by the AGA and are included in the entry fee. Competitors must walk during championship rounds. Push carts are allowed.

### Caddies

- *Caddies:* Caddies are allowed, **provided the caddie is 18 years old or under** and will be denoted by wearing an AGA issued caddie bib.
- *Caddies Cart Policy:* Caddies must walk during the Championship rounds.

### Spectators

- *Spectator Cart Policy:* AGA defers to host club policy in regard to allowing spectator carts at junior championships. If spectator carts are allowed, they will be available on a first-come, first-serve basis.
- *Disability Golf Cart Policy:* In consistency with the Americans with Disabilities Act (ADA), AGA will grant an individual with a bona fide disability a golf cart if the following conditions are met:
  - Requesting individual completes and submits a [Disabled Golf Cart Request Form](#) by the close of entries date;
  - Host club has a golf cart available;
  - Requesting individual pays host club, the appropriate fee;
  - Requesting individual presents to the AGA staff or AGA representative a disability card issued by a government agency.
- Spectator carts must remain on the cart path at all times and spectators must adhere to the club's dress code policy.
- Non-club owned spectator carts are not allowed except as provided in the [AGA Tournament Manual](#).

### Prizes & Awards

- Awards will be presented to the top 5 scorers in the Championship.
- Champion will have their name engraved on the *Bee McWane Trophy* housed at the AGA office.

### Exemptions Earned

- Champion receives exemption into Alabama Girls State Junior for remainder of eligibility.
- Champion receives a five-year (2025-2029) exemption into the Alabama Women's Stroke Play Championship
- Champion receives a five-year (2025-2029) exemption into the Alabama Women's State Amateur Championship
- Champion receives an exemption into the 2025 Southern Junior Cup
- Champion receives an exemption into the 2025 US Girls Junior Championship (USGA)
- Champion receives AJGA exemptions (see AJGA.org website)

### Withdrawals

If an accepted player withdraws for any reason before the close of registration at **11:59pm on Tuesday, May 20, 2025**, the entry fee will be refunded, subject to a \$30.00 service fee. If an accepted player withdraws for any reason after the close of registration and before **11:59pm on Saturday, May 31, 2025**, 75% of the entry fee will be refunded. No refunds will be made for withdrawals after that time.
