## **Championship History**

This year marks the 80<sup>th</sup> playing of the Alabama Boys' State Junior Championship and the first time that RTJ Silver Lakes has hosted the Boys' State Junior Championship. Michael Crocker, of Mobile won the title in 2023 at Goose Pond Colony Resort (Lake Course). The Championship was first played in 1946 with Walter Wood winning the inaugural event. Bobby Wyatt of Mobile holds the record with 4 victories (2007-2010).

## **Host Club Policies**

Cell Phone Policy: Cell phones may only be used on the golf course in case of an emergency, a ruling, entering hole-by-hole scores, viewing tournament leaderboard, weather forecasts, or as a distance measuring device. We ask that phones are set to silent while on club grounds. Silent communications (text, email) may be used inside buildings. Verbal communication (phone calls) must be outside buildings.

Parking: There is a limited amount of parking available at the host club and we ask that players, caddies and family members carpool as much as possible.

*Dress Code:* Appropriate golf attire must be worn. Slacks or Bermuda shorts. No cut-offs, no denim, no cargo pants or cargo shorts. Men must wear shirts with collars and sleeves, tucked in at all times. Non-metal spikes only. Dress code applies to players, caddies and spectators.

Coolers: Personal coolers are not allowed.

*Personal Items:* Make sure not to leave any valuable personal items unattended such as jewelry, wallets, etc. even if they are tucked away inside your golf bag. It is best to leave your valuables locked in your automobile. Neither the AGA nor the host club will be held responsible for any lost or stolen personal items.

## **Practice Rounds and Practice Facility**

You are entitled to **one** practice round on June 16. You may call the golf shop (334) 273-8406 to reserve a practice round tee time. Make sure to identify yourself as an Alabama State Junior Championship participant. It would be helpful if you make your own group before calling. Do

not just show up at the course and expect to be accommodated for a practice round. There is a <u>mandatory</u> \$40.00/player fee for the practice round. Players are limited to playing one ball except from the teeing ground. Players are welcome to use the practice range and putting green throughout the championship.

## **Starting Times**

Starting times for June 17-19 will be available on June 13 by 5:00pm. Check the AGA website at www.alabamagolf.org or call the AGA office.

#### **Championship Format and Schedule**

- Championship field is <u>156 players</u>. Exempt players are accepted at the time of registration. Non-exempt players will be accepted after the close of entries to fill the championship field. If the championship field is oversubscribed, the field will be determined by player ranking, past performance, and handicap index as of June 4, 2024. Players not gaining entry will be placed on the alternate wait list. Wait list alternates are ranked in the same way as the field.
- 54 holes of gross individual stroke play.
- The field will be cut to the low 54 players and ties after 36 holes.
- The lowest score for 54 holes will be the Champion.
- In the event of a tie for the Championship, a hole-by-hole playoff will be held immediately following play. The playoff holes and their order of play will be determined by the Committee.
- Initial groupings will be for two days; the field will be cut and re-paired by score after the second round.

Monday, June 16 All Day: Practice rounds.

7:30am-3:00pm: Player Registration in the Clubhouse Foyer adjacent to the golf shop.

Tuesday, June 17 Round 1: Tee times at 7:00am & 12:00pm off #1 & #10 tees.

Wednesday, June 18 Round 2: Tee times at 7:00am & 12:00pm off #1 & #10 tees.

Cut to low 54 scores and ties. Field re-grouped according to score.

Thursday, June 19 Round 3: Tee times at 7:00am off #1 & #10 tees.

Awards ceremony immediately following play at scoreboard.

#### Pace of Play

The AGA wants all players to enjoy competing in our events. Pace of play may differ depending upon the venue, weather, and course conditions. Every player is accountable for playing at an acceptable pace; therefore, we need your help. Please observe the following guidelines to help ensure a pleasant tournament experience for all:

- Make sure to keep pace with the group in front of you. The group behind should keep pace with your group and so forth.
- Go directly to your ball.
- Be ready to play when it is your turn.
- Keep practice strokes and time taken to read putts to a minimum.
- Play a provisional ball if your original ball may be lost or out of bounds.
- Keep time taken at the snack bar or between nines to a minimum.

If everyone does their part, then 4½ hours should be the maximum time taken to play a round of golf at an AGA tournament. Following the lead of the USGA, the AGA has developed a pace of play policy, based on Rule 5.6b and Model Local Rule 8K that is fair to every competitor. \*Note: a group may receive a "friendly reminder" of their position regardless of pace of play guidelines.

## **Maximum Allowable Time**

The maximum allowable time is the maximum time considered necessary by the Committee for a group to complete its round. This is expressed in a per-hole and aggregate time format and includes all time associated with playing the game, e.g., for rulings and walking times between holes.

Both the specific maximum time allotted per hole and for the completion of 18 holes at AGA championships will be denoted on each player's AGA issued scorecard.

See the complete AGA Pace of Play Policy for the procedure if a group is "out of position" and penalty for breach of Pace of Play Policy.

- A competitor's time to play begins when the competitor has had a reasonable opportunity to reach his or her ball and when it is the competitor's turn to play and can do so without interference or distraction. Penalties are applied individually, but more than one competitor in a group may be penalized.
- In general, competitors in a group are subject to being timed at any time but specifically when the group is deemed to be out of
  position and over the allotted pace of play guidelines.

Note that a group that is out of position at any time may be asked to close the gap regardless of pace of play guidelines. A group is out of position if they are over their maximum acceptable pace of play and more than 15 minutes behind the group ahead of them. The first group off either side is out of position if they are over their maximum acceptable pace of play.

## Range Fees; Push Carts

- Practice Rounds: Practice round fees are not included in the entry fee.
- Championship Site: All range fees during the championship rounds are paid by the AGA and are included in the entry fee. Competitors must
  walk during championship rounds. Push carts are allowed.

#### **Caddies**

- Caddies are allowed, provided the caddie is 18 years old or under
- Caddies must walk during the Championship rounds, push carts are allowed

#### **Spectators**

- Spectator Cart Policy: AGA defers to host club policy in regard to allowing spectator carts at junior championships. If spectator carts are allowed, they will be available on a first-come, first-serve basis.
- Disability Golf Cart Policy: In consistency with the Americans with Disabilities Act (ADA), AGA will grant an individual with a bona fide
  disability a golf cart if the following conditions are met:
  - o Requesting individual completes and submits a <u>Disabled Golf Cart Request Form</u> by the close of entries date;
  - Host club has a golf cart available.
  - o Requesting individual pays host club, the appropriate fee.
  - o Requesting individual presents to the AGA staff or AGA representative a disability card issued by a government agency.
- Spectator carts must remain on the cart path at all times and spectators must adhere to the club's dress code policy.
- Non-club owned spectator carts are not allowed except as provided in the <u>AGA Tournament Manual</u>.

#### **Prizes & Awards**

Awards will be presented to the Top 5 finishers. Champion will have his name engraved on the permanent trophy and may take possession of the trophy for the ensuing year.

## **Exemptions Earned**

- Champion receives exemption into Alabama State Junior for remainder of eligibility.
- Champion receives exemption into the 2025 USGA US Junior Championship
- Champion receives an exemption into the 2026 Alabama State Amateur
- Champion receives a 3-year exemption into the Alabama State Match Play Championship (2025-2027)
- Champion receives automatic spot on 2025 Southern Junior Cup Team
- Champion receives AJGA exemptions (see AJGA.org website)

- This is a soft-spike facility. The penalty for non-compliance is disqualification.

## Withdrawals

Withdrawal: If an accepted player withdraws for any reason before the close of registration at 11:59pm on Tuesday, June 3, 2025, the entry fee will be refunded, subject to a \$30.00 service fee. If an accepted player withdraws for any reason after the close of registration and before 11:59pm on Monday, June 16, 2025, 75% of the entry fee will be refunded. No refunds will be made for withdrawals after that time. Withdrawal: If an accepted player withdraws for any reason before the close of registration at 11:59pm on Tuesday, June 3, 2025, the entry fee will be refunded, subject to a \$30.00 service fee. If an accepted player withdraws for any reason after the close of registration and before 11:59pm on Monday, June 16, 2025, 75% of the entry fee will be refunded. No refunds will be made for withdrawals after that time.
