Entry Fee: \$190 per side (Includes Event Cart/Range Fees)

ELIGIBILITY

Entries are open to amateur golfers who have an active GHIN USGA Handicap Index® and are in good standing of a member club affiliated with one of the following Allied Golf Associations: Alabama Golf Association (AGA), Florida State Golf Association (FSGA), Georgia State Golf Association (GSGA), Mississippi Golf Association (MGA), or Tennessee Golf Association (TGA).

Entries are subject to rejection or withdrawal at any time, including during the event, by the AGA or the host club. The reason for rejection may include unbecoming conduct or unauthorized cell phone use during a stipulated round. All players must conform to the "USGA Rules of Amateur Status" as specified in "The Rules of Golf." For complete residency and eligibility requirements, refer to the [AGA Tournament Manual](#).

ENTRIES AND ONLINE REGISTRATION

Entry is limited to **42** sides. If the event is full at the time of registration, a side may opt to be placed on the alternate wait list. Wait list alternates are ranked according to date/time an entry is received and processed. All sides must register online at <https://www.golfgenius.com/pages/5650264>. Fax, mail-in, or telephone applications are not accepted. The entry of a side is deemed complete when both players have completed the entry process. If a side completes an entry and it is later determined that one or both players are ineligible (e.g., due to an invalid Handicap Index or an amateur status issue), the side's entry will be withdrawn. A player is not permitted to enter the Event as an individual.

- **All entries must be RECEIVED in the AGA office no later than 11:59 PM, July 7, 2026. Entries will not be accepted after that time.**
- Entry fee in the amount of \$190.00, payable by **credit card**, must accompany the entry application.
- Upon successfully completing the entry procedure, an email confirmation will be automatically generated and sent to your email address.

The AGA is not responsible for errors or delays by any internet service provider. Entries are only accepted between the open and close dates as stated above. Confirmation of acceptance is sent to players when their status is determined. Status may be checked at <https://www.golfgenius.com/pages/5650264>. The appropriate entry fee must be paid by each side at time of registration.

Please be advised that all online entry applications for players who are minors, upon date of submission, in the state in which they reside (e.g. Alabama, under the age of 18) must be submitted by a parent/guardian, must list the parent/guardian's name, phone number, and e-mail address. The parent/guardian agrees to be bound by all the terms and conditions on their own behalf and on behalf of the minor player. The AGA reserves the right to require submission of an original signature of the parent/guardian in a confirmation copy of the application upon notification by the AGA to the parent/guardian.

REFUND POLICY

Withdrawal: If an accepted side withdraws for any reason before the close of registration at **11:59 PM on Tuesday, July 7, 2026**, the entry fee will be refunded, subject to a \$30.00 service fee. If an accepted side withdraws for any reason after the close of registration and before **11:59 PM on Sunday, July 12**, 75% of the entry fee will be refunded. No refunds will be made for withdrawals after that time.

No Shows: Players that fail to notify the AGA of their withdrawal and "No Show" their starting time will not receive a refund for any reason. "No Show" players may be subject to suspension from future AGA events.

Alternates: Full refund if player does not enter the event.

All dates and time refer to **date and time of receipt** at the AGA office.

FORMAT

Event is conducted at 18 holes of Stableford scramble. Each partner on one side will start the play of each hole and then select one shot from the side and should mark the location with a ball-marker. Each partner of the side plays their next stroke from the selected location by placing a ball, using the procedures for replacing a ball under Rule 14.2b(2) and 14.2e, within eleven inches (AGA scorecard length) of the selected location, no nearer the hole. This procedure is followed on every shot until a ball is holed. Scoring is as follows: hole in one = 10, triple eagle or better = 8, double eagle = 6, eagle = 4, birdie = 3, par = 2, bogey = 1, double bogey or worse = 0.

DIVISIONS

Teams must choose to compete in the division in which they are eligible, Amateur Men (male/male), Amateur Women (female/female), Amateur Mixed (male/female). Yardages; Male 54 & under: 6,000-6,300, Male 55-64: 5,400-5,800, Male 65+: 4,800-5,100, All Women: 4,800-5,100, regardless of which division they are in. Flights are created in divisions with more than 12 entries. A division with less than 4 teams will compete based on net scores only. Teams are flighted based on the Team Handicap Index.

Gross Champion is the team posting the lowest 18-hole gross score. Net Champion is the team posting the lowest 18-hole net score. Flighted if necessary, and if so, flights are determined based on number of entries using 50% team Handicap Index as of the close of entry date.

Partner substitutions made within a week of the tournament must be approved in advance by the AGA office. On-site substitutions are not permitted.

Approximate yardage (*Note yardage is subject to change)

Male Players 54 & under: 6294 yards (White tees)

Male Players 55-64: 5,595 yards (Gold tees)

Male Players 65 & up, all Female Players: 4911 yards (Teal tees)

SCHEDULE

Wednesday, July 15, 2026: Scramble Round – Shotgun Start at 8:00 AM

CART/RANGE FEES

- *Event Round:* Event round cart/range fees are paid by the AGA and included in the entry fee. Cart use is mandatory for the event round.

CADDIES

- *Caddies:* Caddies are not allowed for event rounds.

SPECTATORS

- *Spectator Golf Cart Policy:* Due to the limited number of available golf carts, spectator carts may not be available during the event.
- *Disability Golf Cart Policy:* Consistent with the Americans with Disabilities Act (ADA), AGA will grant an individual with a *bona fide* disability a golf cart if the following conditions are met:
 - Requesting individual completes and submits a [Disabled Golf Cart Request Form](#) by the close of entries date.
 - The host club has a golf cart available.
 - Requesting individual pays host club, the appropriate fee.
 - Requesting individual presents to the AGA staff or AGA representative a disability card issued by a government agency.
- Spectators are not allowed to ride in a player's golf cart at any time. Non-club owned spectator carts are not allowed except as provided in the [AGA Tournament Manual](#).

PRIZES

- Prizes will be awarded to sides within each flight for the low gross and low net. Any ties for flight winners in both low gross and low net will be determined by a score card playoff using the USGA recommended tie-breaker method. * Teams cannot win prizes for both gross and net (gross takes precedence).

INCLEMENT WEATHER POLICY

If the round is cancelled due to inclement weather, participants will receive a full refund for the event. There will be no rescheduled date. The on-site coordinator and golf staff will make every effort to complete the full 18 holes. However, if the round cannot be completed, a pro-rated refund will be issued based on the number of holes played and the specific circumstances of the event.

RULES OF GOLF; CLOSE OF COMPETITION; SPECIAL REQUESTS

USGA Rules of Golf govern play. Questions will be decided by the on-site Rules Committee whose decision will be final. Notice to Players and local rules are posted at host club and distributed at the starting tee(s). The AGA reserves the right to alter the conditions or schedules as stated, including alteration of the stipulated round(s) at any time during the event. The competition closes when the flight winner awards are presented. Special requests for starting times or pairings may not be granted.

CONDITIONS AGREEMENT

- I agree that the Alabama Golf Association has the right to reject, or withdraw, any entry at any time.
- I am an amateur golfer, and I understand the “Rules of Amateur Status” as established by the United States Golf Association.
- I hereby grant permission to the Alabama Golf Association rights to use my name, image, likeness and sound of my voice as recorded on audio or video devices without payment or any other consideration. I understand that my image may be edited, copied, exhibited, published or distributed and waive the right to inspect or approve the finished product wherein my likeness appears. Additionally, I waive any right to royalties or other compensation arising or related to the use of my image or recording.
- I assume full responsibility for all my acts, whether they are negligent or otherwise, and hold harmless the Alabama Golf Association, its committee members, officers, board of directors, staff, and host club from any and all liability for any event or consequence relating to entry or participation in this event.
