- (1) CLOSE DATE:** January 1, 2022. Trip is subject to availability.
- (2) FULL PRICE:** Golfer : € 3,325 Euros\* (Approx \$4,150 USD as of June 2021) based on 20 participants. Non Golfer: € 2,330 Euros\* (Approx \$2,910 USD as of June 2021) based on 20 participants. \*Per person, based on double occupancy. Additional €620 Euros for single occupancy. Subject to availability. Standard terms and conditions apply.
- (3) DEPOSIT:** A deposit of 20% per participant must be received within 14 days of participant receiving the secure payment link from Sullivan Golf Travel. Deposit will be charged in Euros unless specified otherwise by the participant. Please note USD Rate will be based on exchange rate of the day. Euro Prices remain fixed. Participants will be contacted ahead of deposit being processed.

- (5) FINAL PAYMENT** is due April 27, 2022. You will be emailed a reminder of the amount due approximately 2 weeks prior. **Final balance will be charged in Euros unless specified otherwise by the participant. Please note USD Rate will be based on exchange rate of the day. Euro prices remain fixed. Participants will be contacted ahead of payment being processed.**
- (6) AIRFARE** is not included in this package. Participants are responsible for arranging their own air transportation into Dublin Airport. **A valid passport is required.**
- (7) RESPONSIBILITY:** The suppliers of accommodations and local transportation are acting as independent contractors to the AGA. The AGA shall not be held liable for any act of omission, loss, damage, accident, etc. resulting in conditions beyond its control.
- (8) CANCELLATIONS:** Full refund of deposit given only if written notification is received on or before January 10, 2022. Cancellations received after January 10, 2022 will forfeit the deposit. AGA will make best effort to fill vacancy to permit a refund.
- (9) TRIP INCLUDES:** Eight nights four-star accommodations; five rounds of golf at select courses; luxury chauffeur-driven transfers throughout the trip (includes driver's expenses & gratuity); daily breakfasts; Welcome & Farewell Drinks Receptions; two evening meals (alcohol not included), and a golf gift for each golfer upon arrival. Caddie fees, trolley and gratuities, if used, are extra.
